**Review of “La Petrolifera Italo Albanese’s ”request for revocation of decision no.140 of the Competition Commission dated 10.03.2010”**

In the meeting held on 18.03.2010 went over the case with:

**Objective:** Review of “La Petrolifera Italo Albanese’s ”request for revocation of decision no.140 of the Competition Commission dated 10.03.2010 “Temporary measures taken in the markets of loading/unloading and liquid gas deposit”

**Legal Framework:** Law no.9121, dated 28.07.2003 “For the protection of competition”, article 24d and article 46.

**Competition Commission** after review of the La Petrolifera Italo Albanese’s request for the revocation of decision no.140 of the Competition Commission’s dated 10.03.2010,

**OBSERVES THAT:**

The request from “La Petrolifera ItaloAlbanese” SHA for revocation of decision no.140, dated 10.03.2010 is not in conformity with article 46 of Law no.9121, dated 28.07.2003 “ For the protection of competition”; therefore this request is not based on legal framework or precedents.

Also the request presented from “La Petrolifera ItaloAlbanese” SH.A for the compilation of clauses which enable the application of decision no.140 of the

Competition Commission is not based on law no.9121, dated 28.07.2003 "For the protection of competition".

**FOR THESE REASONS:**

The Competition Commission based on article 24d and article 46 of law no.9121 dated 28.07.2003, "For the protection of competition",

**DECIDED:**

1. Not to revoke decision no.140, dated 10.03.2010 of the Competition Commission, "Temporary measures taken in the markets of loading/unloading and liquid gas deposit".
2. Overturn the request from "La Petrolifera Italo-Albanese"SHA for revocation of decision no.140 dated 10.03.2010 of the Competition Commission for "Temporary measures taken in the markets of loading/unloading and liquid gas deposit".
3. Overturn the request from "La Petrolifera Italo-Albanese"SHA for compilation of new clauses that enable the application of decision no.140 dated 10.03.2010 of the Competition Commission "Temporary measures taken in the markets of loading/unloading and liquid gas deposit".
4. This decision is enforced immediately
5. The Secretary General of the Competition Authority is assigned to notify "La Petrolifera Italo Albanese" SHA of this decision.
